

## Waiver Release for a Minor Volunteer

## Eligibility and Use of Waiver

Loaves & Fishes Rhode Island (LFRI) is a family friendly organization. We highly encourage people of all ages to volunteer with us. If you are a minor, riding on the truck or participating at an LFRI delivery site, we require consent from a parent or guardian. This agreement and waiver release shall be completed (one-time suffices for all occasions) for any minor LFRI volunteer (whether or not accompanied by parent) riding in an LFRI truck, and/or participating at an LFRI delivery site.

## **Volunteer Agreement and Waiver Release**

This agreement is between the person signed below ("Volunteer") and Loaves & Fishes RI ("LFRI"). Volunteer hereby offers his/her services to LFRI to include, but not be limited to, volunteering with LFRI's outreach to chronically homeless and poor people through the delivery of food (which may or may not use an LFRI vehicle), as well as volunteering in any other LFRI program or project it may offer from time to time (collectively the "Volunteer Services").

As a condition of my child being accepted as a LFRI volunteer and being allowed to perform the Volunteer Services, I hereby agree to the following:

Risks Associated with LFRI Volunteer Services. I acknowledge and agree that the nature of the Volunteer Services which are typically performed by an LFRI volunteer may involve (a) physical activity (including without limitation occasionally heaving lifting); (b) contact with unidentified, unfamiliar, and unpredictable persons; (c) travel to and from various unspecified locations, and (d) other potential risk of injury. On behalf of my minor child, I willingly and freely agree to and hereby assume any and all hazards or risk associated with the Volunteer Services, including without limitation, risk of accident, personal injury, or death to my child, person or property which he/she may sustain in connection with participation as a LFRI volunteer.

Limited LFRI Liability. The undersigned hereby releases and covenants not to sue LFRI and its directors, officers, partners, agents, employees, successors, assigns, licensees, sponsors, donors, representatives, volunteers, guests and affiliates from all liability, claims, suits, damages or cause(s) of action, whether known or unknown, arising out of or based upon or relating to my minor child's participation as an LFRI volunteer in the Volunteer Services or any other LFRI related activity or project for any and all property damage, personal injury or death sustained by my child. I will indemnify and hold harmless LFRI from any loss, liability, damage, cost or expense that they may incur as the result of any property damage or injury or death my child may sustain while acting as a LFRI volunteer.

Media Release. I further irrevocably grant to LFRI, its assigns and successors, my consent and full right to photograph, film, audio, or video record my child during the course of volunteering with LFRI, to use such photographs, films, name, image, voice, likeness, biography audio, or video recordings on the LFRI website and other LFRI print, media publications or guides, publicity or promotions, exhibited with or without advertising sponsorships. By this document I release LFRI, their agents, employees or assigns, from any and all claims for damages, libel, slander, invasion of privacy or any other claim based upon the use of my child's likeness, understanding that LFRI warrants not to release or attach any identification associated with such images that it may release into the public domain (posters, website gallery, etc.).

<u>Medical Treatment / Urgent Care for a Minor</u>. I request and authorize LFRI to provide, in their judgment, any immediate medical or emergency care my child may need due to injury or sickness. LFRI can share information concerning the medical condition /treatment of my child to medical personnel or others LFRI representative(s) in its discretions determines is necessary to treat my child.

Having read and received a copy of "Safe Practices for Volunteers" and this Volunteer Agreement and Waiver/Release Form, I agree to the terms and conditions expressed herein. I also understand the LFRI Member Church's representative will retain a copy of this agreement in its records.
